Criteria on adjustment of rating in the performance appraisal

6. DD(LS) had issued a memo dated 12 September 2005 regarding the LSM grade performance appraisal. The Public Service Commission has advised our department to address the problems of over-generous reporting and "C" was the norm for rating performance and competencies. However, members worried about the standard of "C" set by our department and felt anxious. EC members agreed to issue a letter to Grade Management showing our concerns on the fairness of such appraisal system.

Customer Service Enhancement Project (ABC)

7. "A-B-C Performance Improvement System" has been designed for Sports Centres under the Customer Service Enhancement Project with a view to evaluating and maintaining the performance standard of staff in centers and Focus Groups have been formed by the Department to sustain and implement the system. Some members have expressed their concerns on the distribution of work between Venue Managers and AAs for conducting the "A-B-C' System. EC members agreed to keep in view of the situation.

Purchasing Card
